The staff of the St. Johns River Water Management District has completed their review of the environmental resource permit application(s) described below. Based on this review, the District gives notice of its decision for the application(s) described below. The District is providing you this notice because you are either listed as a County Interested Person or you expressed an interest in one or more of these application(s).

The District gives notice of its decision to grant permit(s) for the following application(s):

BMHB Ventures, LLC, 318 Milwaukee Ave, Orange Park, FL 32073-5536 application #177733-5. The project is located in Clay County, Section 16, Township 5 South, Range 25 East. The Environmental Resource Permit application is for the construction and operation of a Stormwater Management System for a 43.10-acre project known as Asbury Creek. The receiving waterbody is Bradley Creek.

Clay County, 477 Houston St, Green Cv Spgs, FL 32043-2438 application #179262-5. The project is located in Clay County, Sections 35 and 36, Township 5 South, Range 25 East; Sections 31 and 32, Township 5 South, Range 26 East. The Environmental Resource Permit application is for a minor modification of Permit No. IND-019-179262-4 for CR 216/Cathedral Oak Parkway (f.k.a. FCC) to include the construction and operation of a 9.66 acre(s) project. The receiving waterbody is Peters Creek.

Clay County Department of Public Works, Po Box 988, Green Cv Spgs, FL 32043-0988, application #75114-6. The project is located in Clay County, Section 31, Township 4 South, Range 26 East. The Environmental Resource Permit application is for the incorporation of an existing public fishing pier and the construction of a public kayak launch that will pre-empt a total of 3,404 square feet and will include a gangway, kayak launch platform, and a floating platform for a project known as Doctors Lake Park Kayak Launch and Submerged Lands Lease.
