## The District gives notice of its decision to grant permit(s) for the following application(s):

Bull Land Holdings LLC, PO Box 51030, Melbourne, FL 32951; Jumbolair Development, LLC, 120 East Dr, Melbourne, FL 32904-1023; application #19552-4. The project is located in Marion County, Sections 16, 17 and 8, Township 14 South, Range 22 East. The Environmental Resource Permit application is for the construction and operation of a Stormwater Management System for a 9.71-acre project known as Jumbolair Development, DRA 3A. The receiving waterbody is a Land-locked basin.

Millrose Properties Florida, LLC, 5505 Waterford District Dr., Miami, FL 33126, application #198872-2. The project is located in Marion County, Section 5, Township 16 South, Range 23 East. The Environmental Resource Permit application is for the construction and operation of a Stormwater Management System for a 10.33-acre project known as Whisper Woods.
