The District gives notice of its decision to grant permit(s) for the following application(s):

Orlando EXP CW LLC, 1355 Terrell Mill Rd, Bldg 1480-200, Marietta, GA 30067 application #91799-11. The project is located in Orange County, Section 20, Township 22 South, Range 32 East. The Environmental Resource Permit application is for a minor modification of Permit No. 91799-1 for Chase Bank (Lot 2) @Lockwood Crossings to include the construction and operation of a 1.11- acre project. The receiving waterbody is Econlockhatchee River.

Lawrence Mack-Harrell, 2926 Lee Shore Loop, Orlando, FL 32820-1947 application #81542-13. The project is located in Orange County, Section 16, Township 22 South, Range 32 East. The Environmental Resource Permit application is for use of the General Permit for Mack-Harrell Boat Dock, a 2,175 total square foot single family dock, with 1,988 SF over wetlands and surface waters, to be constructed. The receiving waterbody is Corner Lake.
