SUBJECT: Notice of Receipt of Consumptive Use Permit Application(s)

In Orange County

Dear Sir/Madam:

This is your notification that the St. Johns River Water Management District (District) has received the Individual Consumptive Use Permit (CUP) application(s) listed below:

RFK90, LLC, 13340 W Colonial Dr, Ste 230, Winter Garden, FL 34787-3978 Consumptive Use Permit application #3232-6, received July 30, 2025. The applicant requests the use of 0.005 million gallons per day (mgd) of groundwater from the Upper Floridan aguifer for 4.69 acres of citrus, 0.004 mgd of groundwater from the Upper Floridan aquifer for irrigation of 1.95 acres of landscape and a maximum daily withdrawal of 0.304 mgd of groundwater from the Upper Floridan aquifer for crop (freeze/frost) protection of citrus. The withdrawals used by this project will consist of Groundwater from FAS - Upper Floridan Aguifer via 3 active wells in Orange County, located in Section 15, Township 22 South, Range 28 East. This project is known as Knuth Grove.

The District issues two types of Individual consumptive use permits (CUPs) - staff-issued CUPs and Governing Board-issued CUPs. Decisions on Individual CUP application(s) will be made at either a District service center (if staff-issued) or at the District's Governing Board meeting where permit applications that have not been delegated to District staff will be acted upon. The Governing Board normally meets on the second Tuesday of the month.

Objections, comments, questions, or information regarding an application for an Individual CUP must be made in writing and received by the Director, Office of Business and Administrative Services, P.O. Box 1429, Palatka, FL 32178-1429, or by e-mail at applicationsupport@sirwmd.com as soon as possible after the notification of the application receipt. The Permit Application Number or the Project Name should be included in the objection. If the District receives a timely objection, the objector will receive written notice of the District's decision (or intended decision) on the permit application.

A Notice of Decision (or Notice of Intended District Decision) will be provided to persons who timely requested individual notice. A request for individual notice must be received by the Director, Office of Business and Administrative Services, prior to the date the Notice of Decision (or Notice of Intended District Decision) is generated. Please note that filing a written objection does not entitle you to a Chapter 120, Florida Statutes, administrative hearing. For more information, call (386) 329-4570.
