The District gives notice of its decision to grant permit(s) for the following application(s):

F Carlyle Platt Ltd Partnership, 2200 Simon Rd, Melbourne, FL 32904-9736 Consumptive Use Permit #239109-1. The District authorizes the use of 0.04 million gallons per day (mgd) of surface water from the borrow pit for water entrained in the mining product through 2032. The withdrawals used by this project will consist of Surface Water from the Borrow Pit via 1 active pump in Brevard County, located in Section 15, Township 28 South, Range 36 East. This project is known as Platt Irrigation Reservoir 7.
