The staff of the St. Johns River Water Management District has completed their review of the consumptive use permit application(s) described below. Based on this review, the District gives notice of its decision to grant permit(s) for the application(s) described below. The District is providing you this notice because you are either listed as a County Interested Person or you expressed an interest in one or more of these application(s).

## The District gives notice of its decision to grant permit(s) for the following application(s):

Adventist Health System, 1919 N Orange Ave, Sunbelt Health Care Corp, Orlando, FL 32804-5567 Consumptive Use Permit #3248-5. By letter modification, the District has updated the permit conditions and permitted allocation in accordance with Section 1.2 of the CFWI Supplemental Applicant's Handbook. The District authorizes the use of 0.053 million gallons per day of surface water and groundwater for irrigation of 20.0 acres of urban landscape at a large hospital complex. The withdrawals used by this project will consist of Surface Water from Lake Estelle via 1 active pump; Groundwater from FAS - Upper Floridan Aquifer via 2 active wells in Orange County, located in Section 13, Township 22 South, Range 29 East. This project is known as Florida Hospital-Rollins Campus.
