Westhaven Apartment Partners, LLC, 3588 Richmond St, Jacksonville, FL 32205-9422, application #198286-2. The project is located in Alachua County, Section 32, Township 9 South, Range 19 East. The Environmental Resource Permit application is for the construction and operation of a Stormwater Management System for a 23.06-acre project known as Westhaven Apartments. The receiving waterbody is an Unnamed Drain.

Westside Baptist Church of Gainesville, Florida, Inc., 10000 W Newberry Rd, Gainesville, FL 32606-5544, application #63725-5. The project is located in Alachua County, Section 31, Township 9 South, Range 19 East. The Environmental Resource Permit application is for Minor Modification of Permit No. 63725-1 for Westside Baptist Church School Addition to include the construction and operation of a 2.75-acre project. The receiving waterbody is an Unnamed Drain.
