The staff of the St. Johns River Water Management District has completed their review of the consumptive use permit application(s) described below. Based on this review, the District gives notice of its decision to grant permit(s) for the application(s) described below. The District is providing you this notice because you are either listed as a County Interested Person or you expressed an interest in one or more of these application(s).

The District gives notice of its decision to grant permit(s) for the following application(s):

RFK90, LLC, 13340 W Colonial Dr, Ste 230, Winter Garden, FL 34787-3978 Consumptive Use Permit #3232-6. The District authorizes the use of 0.005 million gallons per day (mgd) of groundwater from the Upper Floridan aquifer for 4.69 acres of citrus, 0.004 mgd of groundwater from the Upper Floridan aquifer for irrigation of 1.95 acres of landscape and a maximum daily withdrawal of 0.304 mgd of groundwater from the Upper Floridan aquifer for crop (freeze/frost) protection of citrus through 2035. The withdrawals used by this project will consist of Groundwater from FAS - Upper Floridan Aquifer via 3 active wells in Orange County, located in Section 15, Township 22 South, Range 28 East. This project is known as Knuth Grove.
