The staff of the St. Johns River Water Management District has completed their review of the consumptive use permit application(s) described below. Based on this review, the District gives notice of its decision to grant permit(s) for the application(s) described below. The District is providing you this notice because you are either listed as a County Interested Person or you expressed an interest in one or more of these application(s).

## **The District gives notice of its decision to grant permit(s) for the following application(s):**

Yu An Farms, PO Box 217, Elkton, FL 32033-0217 Consumptive Use Permit #128846-4. The District authorizes the use of 0.23 million gallons per day (mgd) of groundwater from the Upper Floridan aquifer for irrigation of 122.16 acres of agricultural cultivated crops and 0.04 mgd of groundwater from the Upper Floridan aquifer for backup irrigation of agricultural cultivated crops through 2045. The withdrawals used by this project will consist of Groundwater from FAS - Upper Floridan Aquifer via 3 active wells in St. Johns County, located in Section 25, Township 8 South, Range 28 East. This project is known as Yu An Farms - Middleton Field.
