## The District gives notice of its decision to grant permit(s) for the following application(s):

Florida Fish and Wildlife Conservation Commission, 600 S Meridian St, Tallahassee, FL 32399 application #140484-5. The project is located in Brevard County, Section 2, Township 28 South, Range 37 East. The Environmental Resource Permit application is for Authorization to use Sovereign Submerged Lands in the form of Letter of Consent for a 0.95-acre living shoreline protection project known as Bird Island Living Shoreline Restoration Project. The receiving waterbody is Indian River Lagoon.
