The District gives notice of its decision to grant permit(s) for the following application(s):

Aventuur Jax Propco, LLC, 2205 Ocean Ave, Venice, CA 90291-4627 application #126414-81. The project is located in Duval County, Section 8, Township 4 South, Range 28 East, and includes 47.0-acres. The Environmental Resource Permit application is for the construction and operation of a stormwater management system for the Jax Surf Park development in accordance with the plans received by the District on August 15, 2025. The receiving waterbody is Big Davis Creek.

Seaside School Consortium Properties, LLC, 2865 Mayport Rd, Jacksonville, FL 32233-4673 application #151322-4. The project is located in Duval County, Section 37, Township 2 South, Range 29 East, and includes 0.28-acres. The Environmental Resource Permit application is for Modification of a stormwater management system to accommodate interior campus improvements including a new building, pavilion, and basketball court for a project known as Seaside Charter School. The receiving waterbody is Sherman Creek.

The Environmental Resource Permit application is for the construction and operation of a Stormwater Management System for a 0.75-acre project known as 10th Street Warehouse.
