Based on this review, the District gives notice of its decision for the application(s) described below. The District is providing you this notice because you are either listed as a County Interested Person or you expressed an interest in one or more of these application(s).

## The District gives notice of its decision to grant permit(s) for the following application(s):

First Coast Energy, LLP, 6867 Spouthpoint Drive N, Jacksonville, FL 32216 application #113098-26. The project is located in St. Johns County, Section 11, Township 5 South, Range 27 East. The Environmental Resource Permit application is for Construction and operation of a Stormwater Management System for a 9.84-acre project known as Veterans Commercial Mass Grading. The receiving waterbody is Cunningham Creek.

FDOT, District 2, 1109 S Marion Ave, Lake City, FL 32025-5874 application #113964-46. The project is located in St. Johns County, Sections 2 and 4, Township 6 South, Range 27 East. The Environmental Resource Permit application is for the operation of a temporary mixing zone for a 0.50-acre project known as Mixing Zone for SR 23 over Trout Creek, Bridges 7 & 8. The receiving waterbody is Trout Creek.

Whetstone Properties, LLC, 400 Old Quarry Rd, St Augustine, FL 32080-5330 application #155405-3. The project is located in St. Johns County, Section 9, Township 7 South, Range 29 East, and includes 5.05-acres.
