The District gives notice of its decision to grant permit(s) for the following application(s):

VB Three Oaks, LLLP, Ste 200, 12270 SW 3rd St, Plantation, FL 33325-2811 Consumptive Use Permit application #148387-1. The District authorizes the use of an irrigation schedule of days different than the schedule set for in rule 40C-2.042(2), for landscape irrigation one additional day per week. The withdrawals used by this proposed project will consist of surface water from wet detention pond via 1 active pump in Indian River County, located in Section: 1, Township: 33 South, Range: 38 East, known as Villas at Three Oaks.
