The District gives notice of its decision to grant permit(s) for the following application(s):

City of Lake Mary, 100 N Country Club Rd, Lake Mary, FL 32746-3208 Consumptive Use Permit application #8282-10. The District authorizes the change of due date for the annual wetlands monitoring report from January 31st to March 31st to be consistent with the annual reporting requirements of the recently issued City of Sanford CUP. The withdrawals used by this proposed project will consist of connection point from Seminole County via 1 active connection point; groundwater from FAS - Upper Floridan Aquifer via 5 active wells in Seminole County, located in Sections: 5, 7 and 8, Township: 20 South, Range: 30 East, known as City of Lake Mary.
