The staff of the St. Johns River Water Management District has completed their review of the consumptive use permit application(s) described below. Based on this review, the District gives notice of its decision to grant permit(s) for the application(s) described below. The District is providing you this notice because you are either listed as a County Interested Person or you expressed an interest in one or more of these application(s).

The District gives notice of its decision to grant permit(s) for the following application(s):

May & Whitaker Family Partnership Ltd, PO Box 2267, Umatilla, FL 32784-2267 Consumptive Use Permit #88-5. The District authorizes a change in use type from fern to fern, blueberries, and citrus and the use of 0.154 million gallons per day (mgd) for irrigation of fern, citrus, and blueberries and 0.049 mgd for freeze protection of fern, citrus, and blueberries. A back-up allocation of 0.102 mgd is authorized for five years. The withdrawals used by this existing project will consist of groundwater from FAS - Upper Floridan Aguifer via 7 active wells in Lake County, located in Sections: 29 and 30, Township: 18 South, Range: 26 East, known as Flowertree Nursery.
