Fountains of Fellsmere, LLC, Ste 204, 930 W Indiantown Rd, Jupiter, FL 33458-6841 application #144485-1. The project is located in Indian River County, Section: 0, Township: 31 South, Range: 37 East, and includes 10.7891 acres. The Environmental Resource Permit application is for the construction of an assisted living facility and a new surface water management system. The project is known as Fountains of Fellsmere. The receiving waterbody is St Sebastian River.
