The District gives notice of its decision to grant permit(s) for the following application(s):

Chick-fil-A, Inc., 5200 Buffington Rd, Atlanta, GA 30349-2945 application #84016-9. The project is located in Lake County, Section: 9, Township: 22 South, Range: 26 East, and includes 1.14 acres. The Environmental Resource Permit application is for a minor modification of Permit #84016-2 to include the modifications to an existing restaurant known as Chick-fil-A. The receiving waterbody is unnamed lake.

South Lake Hospital, Inc., 1900 Don Wickham Dr, Clermont, FL 34711-1979 application #146986-2. The project is located in Lake County, Section: 7, Township: 21 South, Range: 25 East, and includes 22.72 acres. The Environmental Resource Permit application is for authorization of a stormwater management system with stormwater treatment by retention to serve the project known as South Lake Hospital Health Pavilion MOD. The receiving waterbody is Palatlahaka River.
