## The District gives notice of its decision to grant permit(s) for the following application(s):

Mid-Florida Freezer Warehouses, Ltd., 400 Harbor Dr, Cape Canaveral, FL 32920-2043 application #146007-1. The project is located in Orange County, Section: 6, Township: 21 South, Range: 28 East; Section: 1, Township: 21 South, Range: 27 East, and includes 141.42 acres. The Environmental Resource Permit application is for mass grading, stabilization of mass graded area, and retention sump area. No impervious area proposed under this application. The project is known as Wekiva Parkway Industrial Park Mass Grading Plan. The receiving waterbody is Lake Apopka.

William Parramore, 2615 Hempel Ave, Windermere, FL 34786-8309 application #147703-1. The project is located in Orange County, Section: 16, Township: 23 South, Range: 30 East, and includes 4.0 acres. The Environmental Resource Permit application is for mass grading of a future project area with associated stormwater management system, wetland impacts and wetland mitigation plan.
