### **The District gives notice of its decision to grant permit(s) for the following application(s):**

Tru-Gas of Florida, Inc., 3500 Fell Rd, W Melbourne, FL 32904-7502 Consumptive Use Permit application #69928-3. The District authorizes the use of 0.004 million gallons per day (mgd) of groundwater for augmentation of a one acre pond. The withdrawals used by this proposed project will consist of groundwater from the Surficial Aquifer via 1 active well in Brevard County, located in Section: 8, Township: 28 South, Range: 37 East, known as Arrowood.

City of Palm Bay, 1150 DeGroodt Rd SW, Palm Bay, FL 32908-7117, Consumptive Use Permit application #149647-1. The District authorizes the use of 0.06 million gallons per day (mgd) for water based recreation. The withdrawals used by this proposed project will consist of groundwater from the Upper Floridan Aquifer via 1 active well in Brevard County, located in Section: 25, Township: 28 South, Range: 37 East, known as Vets Park Swimming Pond.
