## The District gives notice of its decision to grant permit(s) for the following application(s):

Indian River County, Bldg A, 1801 27th St, Vero Beach, FL 32960-3388 application #18729-5. The project is located in Indian River County, Sections: 23, 25 and 26, Township: 32 South, Range: 39 East, and includes 2.85 acres. The Environmental Resource Permit application is for a modification to existing surface water management system to serve a sidewalk along Indian River Blvd and 53rd St. The project is known as Indian River Blvd Sidewalk 37th Street to 53rd Street. The receiving waterbody is Indian River Lagoon.
