Florida Department of Transportation, 1109 S Marion Ave, Lake City, FL 32025-5874, application #148975-1. The project is located in Clay County, Sections: 27, 28, 33 and 34, Township: 6 South, Range: 24 East, and includes 17.28 acres. The Environmental Resource Permit application is for construction of a surface water management system for the replacement of the State Road 21 Bridge over the South Fork of Black Creek. The receiving waterbody is South Fork Black Creek.
