The staff of the St. Johns River Water Management District has completed their review of the environmental resource permit application(s) described below. Based on this review, the District gives notice of its decision for the application(s) described below. The District is providing you this notice because you are either listed as a County Interested Person or you expressed an interest in one or more of these application(s).

### **The District gives notice of its decision to grant permit(s) for the following application(s):**

Chesnut Plantation, LLC, 2050 Biscayne Blvd, Miami, FL 33137, application #148461-1. The project is located in Alachua County, Section: 29, Township: 10 South, Range: 19 East, and includes 33.1 acres. The Environmental Resource Permit application is for construction of a new single-family residential subdivision known as Chesnut Plantation. The receiving waterbody is groundwater.

University of Florida PPD, Bldg 700, 3280 Radio Rd, Gainesville, FL 32611-1917, application #15570-34. The project is located in Alachua County, Section: 12, Township: 10 South, Range: 19 East, and includes 2.26 acres. The Environmental Resource Permit application is for expansion of previously permitted stormwater Basin 1-A for the construction of a new building and parking area. The project is known as UF Golf Course Renovations. The receiving waterbody is Lake Alice.
