### **The District gives notice of its decision to grant permit(s) for the following application(s):**

Flagler County, Bldg 2, 1769 E Moody Blvd, Bunnell, FL 32110-5991, application #139862-3. The project is located in Flagler County, Sections: 17, 20, 39 and 40, Township: 10 South, Range: 31 East, and includes 33.19 acres. The Environmental Resource Permit application is for construction of a surface water management system to serve the project known as North Mala Compra Basin Drainage Improvements. The receiving waterbody is Intracoastal Waterway.
