The project is located in Lake County, Sections: 21 and 22, Township: 19 South, Range: 25 East, and includes 13.2 acres. The Environmental Resource Permit application is for authorization of a stormwater management system to serve the project known as LEE - Taxi-Lane Extension and Seaplane Ramp. The receiving waterbody is Lake Harris.

The project is located in Lake County, Section: 35, Township: 21 South, Range: 25 East, and includes 43.92 acres. The Environmental Resource Permit application is for authorization of a stormwater management system to serve the project known as Cascades at Groveland - Phase 6. The receiving waterbody is Schoolhouse Lake.
