The staff of the St. Johns River Water Management District has completed their review of the environmental resource permit application(s) described below. Based on this review, the District gives notice of its decision for the application(s) described below. The District is providing you this notice because you are either listed as a County Interested Person or you expressed an interest in one or more of these application(s).

The District gives notice of its decision to grant permit(s) for the following application(s):

Florida Department of Transportation, District Five, 719 S Woodland Blvd, DeLand, FL 32720-6834 application #149606-1. The project is located in Osceola County, Sections: 26 and 35, Township: 29 South, Range: 33 East, and includes 17.3 acres. The Environmental Resource General Permit application is for a safety improvements project on State Road 15 by clearing vegetation within 18 feet of the outside travel lane, per the FDOT Plans Preparation Manual and milling and resurfacing a section of SR 15. The project is known as State Road 15. The receiving waterbody is wetlands.
