Based on this review, the District gives notice of its decision for the application(s) described below. ### **The District gives notice of its decision to grant permit(s) for the following application(s):**

Florida Department of Transportation, District Five, 719 S Woodland Blvd, DeLand, FL 32720-6834 application #149606-1. The project is located in Osceola County, Sections: 26 and 35, Township: 29 South, Range: 33 East, and includes 17.3 acres. The Environmental Resource General Permit application is for a safety improvements project on State Road 15 by clearing vegetation within 18 feet of the outside travel lane, per the FDOT Plans Preparation Manual and milling and resurfacing a section of SR 15. The project is known as State Road 15. The receiving waterbody is wetlands.
