## The District gives notice of its decision to grant permit(s) for the following application(s):

Circle K Stores Inc., 12911 N Telecom Pkwy, Temple Terr, FL 33637-0907, application #149239-1. The project is located in Marion County, Section: 1, Township: 15 South, Range: 22 East, and includes 2.62 acres. The Environmental Resource Permit application is for the construction of a commercial development known as Circle K Stores #5048, Silver Springs Blvd (SR 40). The receiving waterbody is landlocked basin.

Burnyzz Speed Shop, 1 Aspen Rd, Ocala, FL 34480-8689, application #118049-2. The project is located in Marion County, Section: 12, Township: 16 South, Range: 22 East, and includes 7.89 acres. The Environmental Resource Permit application is for modification of a stormwater management system to serve a commercial development known as Burnyzz Speed Shop. The receiving waterbody is landlocked basin.
