Based on this review, the District gives notice of its decision for the application(s) described below. The District is providing you this notice because you are either listed as a County Interested Person or you expressed an interest in one or more of these application(s).

## The District gives notice of its decision to grant permit(s) for the following application(s):

Sonoc Company LLC, 4310 Pablo Oaks Ct, Jacksonville, FL 32224-9631 application #87432-279. The project is located in St. Johns County, Sections: 31 and 32, Township: 4 South, Range: 29 East, and includes 0.25 acres. The Environmental Resource Permit application is for modification to the design of wet detention pond L1-SMF. The project is known as Nocatee Master Stormwater Management Plan Phase I - L1-SMF System. The receiving waterbody is Intracoastal Waterway [Tolomato River].

Six Mile Creek Community Development District, Ste 114, 475 W Town PI, St Augustine, FL 32092-3649 application #104176-11. The project is located in St. Johns County, Section: 41, Township: 7 South, Range: 28 East, and includes 15.88 acres. The Environmental Resource Permit application is for construction of a surface water management system to serve a 36-lot single family residential development known as Trailmark Phase 7. The receiving waterbody is Sixmile Creek.

St. Johns County Sheriff Department, 4015 Lewis Speedway, St Augustine, FL 32084-8611 application #150535-1. The project is located in St. Johns County, Section: 17, Township: 7 South, Range: 29 East, and includes 49.16 acres. The Environmental Resource Permit application is for construction of a master stormwater management system and rough grading of the site for the project known as SJC Sheriff's Office Training Facility - Master Drainage Plan and Pond Excavation. The receiving waterbody is Moultrie Creek.

Pet Paradise - Racetrack, LLC, 5130 University Blvd W, Jacksonville, FL 32216-5940 application #80424-29. The project is located in Duval and St. Johns Counties, Sections: 3 and 47, Township: 5 South, Range: 28 East; Sections: 34 and 48, Township: 4 South, Range: 28 East, and includes 1.93 acres. The Environmental Resource Permit application is for construction of a commercial facility on outparcel 1 within the master permitted stormwater management system. The project is known as Pet Paradise - Bartram. The receiving waterbody is Durbin Creek.
