GH&G Maricamp, LLC, Ste B-3, 101 S Bay Blvd, Anna Maria, FL 34216-9800 application #43592-2. The project is located in Marion County, Sections: 22 and 27, Township: 15 South, Range: 22 East, and includes 2.97 acres. The Environmental Resource Permit application is for authorization of a surface water management system to serve a proposed convenience store and gas station. The project is known as Wawa - Maricamp & 24th. The receiving waterbody is groundwater.
