## **The District gives notice of its decision to grant permit(s) for the following application(s):**

Clermont Motors, LLC, 15859 SR 50, Clermont, FL 34711-9533 application #87918-5. The project is located in Lake County, Section: 27, Township: 22 South, Range: 26 East, and includes 15.75 acres. The Environmental Resource Permit application is for modification of a stormwater management system to serve a commercial expansion known as Napleton Clermont Addition and Renovation. The receiving waterbody is Lake Apopka.

FDACS, 407 S Calhoun St, Tallahassee, FL 32399-6555 application #145600-3. The project is located in Lake County, Sections: 35 and 36, Township: 18 South, Range: 26 East; Section: 2, Township: 19 South, Range: 26 East, and includes 5.005 acres. The Environmental Resource Permit application is for modification of Permit #145600-1 for the construction and operation of a project known as Trout Lake HWTT Dry Weather Inflow Forcemain. The receiving waterbody is Trout Lake.

Florida Hospital Waterman Inc., 1000 Waterman Way, Tavares, FL 32778-5266 application #63717-9. The project is located in Lake County, Section: 21, Township: 19 South, Range: 26 East, and includes 4.4 acres. The Environmental Resource Permit application is for a minor modification of Permit #63717-1 for the construction and operation of a project known as Florida Hospital Waterman - Emergency Department Addition. The receiving waterbody is Lake Etowah.

Chickasaw Holdings, LLC, 3361 Rouse Road, Suite 235, Orlando, FL 32817 application #113456-4. The project is located in Lake County, Section: 21, Township: 19 South, Range: 26 East, and includes 1.23 acres. The Environmental Resource Permit application is for a letter modification of Permit #113456-1 for construction of a project known as Mister Car Wash. The receiving waterbody is Lake Junietta.
