## The District gives notice of its decision to grant permit(s) for the following application(s):

Anderson Columbia Co., Inc., 871 NW Guerdon St, Lake City, FL 32055-4346 application #146731-2. The project is located in Clay County, Section: 32, Township: 4 South, Range: 23 East, and includes 91.6 acres. The Environmental Resource Permit application is for expanding the existing borrow pit to the eastern property line and increasing the project area to 91.6 acres. The project is known as Highlands Borrow Pit Expansion. The receiving waterbody is North Fork Black Creek.

Hagan Ace Hardware of Blanding Inc., 1022 Blanding Blvd, Orange Park, FL 32065-6702 application #150474-1. The project is located in Clay County, Section: 40, Township: 4 South, Range: 25 East, and includes 0.79 acres. The Environmental Resource Permit application is for authorization of a surface water management system to serve a new greenhouse. The project is known as New Greenhouse for Hagan Ace - Blanding. The receiving waterbody is Ridgewood Drain to Little Black Creek.
