The staff of the St. Johns River Water Management District has completed their review of the environmental resource permit application(s) described below. Based on this review, the District gives notice of its decision for the application(s) described below. The District is providing you this notice because you are either listed as a County Interested Person or you expressed an interest in one or more of these application(s).

The District gives notice of its decision to grant permit(s) for the following application(s):

RaceTrac Petroleum, Inc., Ste 100, 3225 Cumberland Blvd Se, Atlanta, GA 30339-6408 application #49812-2. The project is located in Seminole County, Section: 16, Township: 21 South, Range: 29 East, and includes 0.05 acres. The Environmental Resource Permit application is for the addition of 2,099 sf of impervious surface as part of the remodeling of RaceTrac Altamonte Springs #629. The receiving waterbody is Wekiva River.

City of Winter Springs, 1126 E State Road 434, Winter Spgs, FL 32708-2715 application #22353-7. The project is located in Seminole County, Section: 6, Township: 21 South, Range: 31 East, and includes 0.1 acres. The Environmental Resource Permit application is for improvements which include adding a 12-ft wide westbound right-turn deceleration lane, along State Road 434, at the Winter Springs City Hall entrance. Additional work associated with the turn lane includes: the relocation of one (1) curb inlet, the relocation of one (1) ditch bottom inlet, and the addition of one (1) curb inlet. The project is known as State Road 434 and City Hall Access Drive Intersection Improvements. The receiving waterbody is Lake Jesup.
