## **The District gives notice of its decision to grant permit(s) for the following application(s):**

Seaside Landings Homeowners Association, Inc., Ste 404, 1100 5th Ave S, Naples, FL 34102-6419 application #87306-5. The project is located in Flagler County, Sections: 19 and 37, Township: 12 South, Range: 32 East; Section: 38, Township: 12 South, Range: 31 East, and includes 23.16 acres. The Environmental Resource Permit application is for authorization of a multi-slip pier, a parking lot, dredging and mangrove trimming. The project is known as Seaside Landings, South Cove, Municipal Pier. The receiving waterbody is Halifax River (Intracoastal Waterway).

Tearoc of Florida Inc., 4490 N US Highway 1, Bunnell, FL 32110-4374 application #82381-2. The project is located in Flagler County, Section: 22, Township: 11 South, Range: 30 East, and includes 4.9959 acres. The Environmental Resource Permit application is for construction of a surface water management system to serve a storage facility known as Alamo Storage Phase 2. The receiving waterbody is St. Joe Canal.
