## The District gives notice of its decision to grant permit(s) for the following application(s):

Brooks Health System, 3599 University Blvd S, Jacksonville, FL 32216-4252, application #113886-3. The project is located in Clay County, Section: 30, Township: 4 South, Range: 25 East, and includes 58.5 acres. The Environmental Resource Permit application is for construction of a health care facility known as Brooks Old Jennings Road Campus. The receiving waterbody is Little Black Tributary 1.

Southern Baptist Hospital of Florida Inc., 800 Prudential Dr, Jacksonville, FL 32207-8202 application #56338-60. The project is located in Clay County, Sections: 16, 17, 20, 38, 4, 5, 8 and 9, Township: 5 South, Range: 26 East, and includes 1.42 acres. The Environmental Resource Permit application is for modification of Permit #56338-43 for the construction of an ambulatory surgery center at Baptist Medical Center, Clay County. The project is known as Fleming Island Plantation (North Portion - Baptist Medical Center South. The receiving waterbody is Swimming Pen Creek.
