The staff of the St. Johns River Water Management District has completed their review of the environmental resource permit application(s) described below. Based on this review, the District gives notice of its decision for the application(s) described below. The District is providing you this notice because you are either listed as a County Interested Person or you expressed an interest in one or more of these application(s).

The District gives notice of its decision to grant permit(s) for the following application(s):

DDI Inc., 4314 Pablo Oaks Ct, Jacksonville, FL 32224-9631, application #126414-11. The project is located in Duval County, Sections: 17, 5 and 8, Township: 4 South, Range: 28 East, and includes 0.19 acres. The Environmental Resource Permit application is for modification of a previously issued permit to include additional wetland impacts and utility installation. The project is known as Bayard Parcel - Mitigation Modification. The receiving waterbody is Big Davis Creek.

Caven Dental, 8708 Perimeter Park Blvd, Jacksonville, FL 32216-6354 application #86003-17. The project is located in Duval County, Sections: 20 and 29, Township: 3 South, Range: 28 East, and includes 0.65 acres. The Environmental Resource Permit application is for construction of a stormwater collection and conveyance system to serve a commercial project known as Caven Dental Office - Campfield Common - Parcel 10. The receiving waterbody is Puncheon Gum Swamp.

City of Jacksonville, 214 N Hogan St # 10, 10th Floor, Jacksonville, FL 32202-4240 application #152114-1. The project is located in Duval County, Section: 36, Township: 2 South, Range: 25 East, and includes 0.28 acres. The Environmental Resource Permit application is for modifications to the Hyde Park Circle stormwater collection system to improve neighborhood drainage. The project is known as Hyde Park Circle Drainage Improvements. The receiving waterbody is Wills Branch.

OLT II, Inc., 1371 W Rahn Rd, Dayton, OH 45459-1431 application #146092-2. The project is located in Duval County, Section: 4, Township: 2 South, Range: 27 East, and includes 0.41 acres. The Environmental Resource Permit application is for construction of a parking area to be accommodated by an existing permitted surface water management system. The project is known as Parking Addition at Dolphin Pointe Landing. The receiving waterbody is St. Johns River.
