This is your notification that the St. Johns River Water Management District (District) has received the Individual Consumptive Use Permit (CUP) application(s) listed below:

Joyce & Charles Caldwell, PO Box 490197, Leesburg, FL 34749-0197 Consumptive Use Permit application #88885-4. By letter modification filed on 1/9/2018, the applicant proposes to combine existing Consumptive Use Permits (CUP) 2678 into 88885 and modify the allocation for CUP 2678 from 0.038 million gallons per day (mgd) of groundwater for irrigation of ferns to irrigation of citrus. There is no overall change to the existing allocations. No changes are proposed to the existing expiration date of 7/25/2023. The withdrawals used by this existing project will consist of surface water from Tailwater Pond via 1 active pump; groundwater from FAS - Upper Floridan Aquifer via 4 active wells in Lake County, located in Sections: 3 and 4, Township: 19 South, Range: 25 East. This project is known as Orange Bend Harvesting.

Superior Construction Company, 29100 County Road 46a, Sorrento, FL 32776-7770 Consumptive Use Permit application #152368-1, received 1/18/2018. The applicant proposes the use of 0.098 million gallons per day (mgd) of groundwater from the Surficial Aquifer for construction dewatering. The withdrawals used by this proposed project will consist of groundwater from Surficial Aquifer via 2 proposed wells in Lake County, located in Sections: 21 and 28, Township: 19 South, Range: 29 East. This project is known as Wekiva Parkway Section 6.

The file(s) containing the permit application(s) are available for inspection Monday through Friday, except for District holidays, 8 a.m. to 5 p.m. at the District's Headquarters, 4049 Reid St., Palatka, FL 32177-2529. You may also view files at one of the District's service centers, but you should call service center staff in advance to make sure that the files are at a specific service center. Service center contact information is available online at www.sjrwmd.com/contactus/offices.html. Additionally, most permit application file documents can be viewed online at www.sjrwmd.com/permitting/index.html by selecting the topic of interest from the "Find permits and applications" heading.

The District issues two types of Individual consumptive use permits (CUPs) – staff-issued CUPs (where the proposed consumptive use does not exceed 500,000 gallons per day on an average annual basis), and Governing Board-issued CUPs (where the proposed consumptive use exceeds 500,000 gallons per day on an average annual basis or the District receives a timely substantial objection). Decisions on applications for a staff-issued Individual CUP will be made at the District's service center where the application is processed, unless the application is upgraded to an application for a Governing Board-issued Individual CUP will be whether the Governing Board will consider the application at a noticed Board meeting. The Governing Board normally meets on the second Tuesday of the month.

A substantial objection to an application for a staff-issued Individual CUP must be made in writing and filed with (received by) the Director, Office of Business and Administrative Services, P.O. Box 1429, Palatka, FL 32178-1429, or by e-mail at <u>applicationsupport@sjrwmd.com</u>, within 14 days of notification of the application. Please include either the Permit Application Number or the Project Name in the objection. Notification of the application is either the fifth day after the date on which the written notice is deposited in the U.S. mail (for those persons who receive actual notice by U.S. mail), the date on which the notice is published in the

newspaper (if actual notice is not provided by U.S. mail or e-mail). A "substantial objection" means a written statement directed to the District that identifies the objector, concerns hydrologic or environmental impacts of the proposed consumptive use, and relates to applicable rule criteria. A timely substantial objection will cause an application for a staff-issued Individual CUP to be considered an application for a Governing Board-issued Individual CUP. If the District receives a timely substantial objection from you, then you will receive written notice of the District's intended decision on the permit application.

Decisions on applications for a Governing Board-issued Individual CUP will be made by the District's Governing Board. Notice of Intended District Decision will be provided to persons who have requested individual notice. A request for individual Notice of Intended District Decision on an application for a Governing Board-issued Individual CUP must be received by the Director, Office of Business and Administrative Services, prior to the date the Notice of Intended District Decision is generated. For those applications, you are advised to notify the District within 14 days of notification of the application if you have questions, objections, comments or information regarding the proposed consumptive use. If you make a written request to the District for additional information. Please note that filing a written objection does not entitle you to a Chapter 120, Florida Statutes, administrative hearing.
