## **The District gives notice of its decision to grant permit(s) for the following application(s):**

Villa Farms Luxury Community, 7300 Crill Ave, Palatka, FL 32177-9212 Consumptive Use Permit application #50308-3. The District authorizes the use of 0.0252 million gallons per day (mgd) of groundwater from the Upper Floridian aquifer to irrigate 12 acres of landscape and one swimming pool. The withdrawals used by this proposed project will consist of groundwater from FAS - Upper Floridian aquifer via 1 active well in Putnam County, located in Section: 9, Township: 10 South, Range: 26 East, known as Villa Farms.
