The District gives notice of its decision to grant permit(s) for the following application(s):

BW 27 441 LLC, Ste 200, 3708 W Swann Ave, Tampa, FL 33609-4506, application #150408-2. The project is located in Marion County, Section: 36, Township: 16 South, Range: 22 East, and includes 1.75 acres. The Environmental Resource Permit application is for construction of a stormwater management system to serve a new convenience store and gas station facility. The project is known as Wawa - Belleview. The receiving waterbody is landlocked basin.
