The District gives notice of its decision to grant permit(s) for the following application(s):

Taurus CD 186 Balmy Beach FL LP, Ste 200, 610 N Wymore Rd, Maitland, FL 32751-4239 application #48546-4. The project is located in Seminole County, Section: 7, Township: 21 South, Range: 29 East, and includes 9.52 acres. The Environmental Resource Permit application is for modification of the previously permitted dry retention pond to a stormwater harvesting pond for the project known as Walmart Stormwater Pond Modification. The receiving waterbody is Border Lake.

St Peter's Episcopal Church, 700 Rinehart Rd, Lake Mary, FL 32746-4875 application #48424-4. The project is located in Seminole County, Section: 6, Township: 20 South, Range: 30 East, and includes 0.25 acres. The Environmental Resource Permit application is for a modification to the existing stormwater management system to serve a new sanctuary building known as St. Peter's Episcopal Church. The receiving waterbody is Existing Borrow Pit and Lake Monroe.
