The District gives notice of its decision to grant permit(s) for the following application(s):

Orange County, 400 E South St, Orlando, FL 32801-2816 application #70054-4. The project is located in Orange County, Section: 24, Township: 21 South, Range: 28 East, and includes 1.5 acres. The Environmental Resource Permit application is for a minor modification of Permit #70054-3 to include the construction and operation of a project known as Journey Park Playground Installation. The receiving waterbody is Bear Lake.

CHC-845 S Orange Blossom Trail Apopka FL LLC, c/o Egoavil & Horvat, PLLC, 2525 Ponce De Leon Blvd, Ste 300, Coral Gables, FL 33134 application #20244-3. The project is located in Orange County, Sections: 11 and 14, Township: 21 South, Range: 28 East, and includes 1.07 acres. The Environmental Resource Permit application is for construction of a stormwater management system to serve an outparcel within a master system known as Church's Chicken Apopka Land Regional Shopping Center 11, Lot 7. The receiving waterbody is Wekiva River.
