## The District gives notice of its decision to grant permit(s) for the following application(s):

20978E Colonial Dr LLC, 210 S Magnolia, Tampa, FL 33606 application #182639-2. The project is located in Orange County, Section 36, Township 22 South, Range 32 East, and includes 0.55-acres. The Environmental Resource Permit application is for Minor Modification of Permit No. 182639-1 for CPG of Florida Borrow Area to include the construction of right and left turn lanes with entrance to a 54.9-acre project. The receiving waterbody is Christmas Creek and Savage Creek.

Chick-Fil-A Inc, 5200 Buffington Rd, Atlanta, GA 30349-2945 application #56709-5. The project is located in Orange County, Section 3, Township 22 South, Range 30 East. The Environmental Resource Permit application is for Minor Modification of Permit No. 56709-2 for Costco Wholesale- University and Forsyth: Chick-Fil-A to include the construction and operation of a 1.27-acre project. The receiving waterbody is Little Econlockhatchee River.
