## The District gives notice of its decision to grant permit(s) for the following application(s):

Space Coast Town Centre I, LLC, 7845 Fairway Dr, Ste 430, Miami Lakes, FL 33014 application #108610-15. The project is located in Brevard County, Section 3, Township 28 South, Range 36 East. The Environmental Resource Permit application is for Construction and operation of a Stormwater Management System for a 4.54 -acre project known as SCTC- Nebula Way. The receiving waterbody is Melbourne Tillman Canal.

Professional Resource Development, Inc., 270 West Plant St, Suite 210, Winter Garden, FL 34787 UNITED STATES application #149177-10. The project is located in Brevard County, Section 3, Township 30 South, Range 37 East. The Environmental Resource Permit application is for Minor Modification of Permit No. 149177-7 for Dental Office at the Shoppes at Cypress Bay to include the construction and operation of a 1.12-acre project. The receiving waterbody is Indian River Lagoon.
