Based on this review, the District gives notice of its decision to grant permit(s) for the application(s) described below. The District is providing you this notice because you are either listed as a County Interested Person or you expressed an interest in one or more of these application(s).

The District gives notice of its decision to grant permit(s) for the following application(s):

Albert B Johnston, PO Box 245, Bunnell, FL 32110-0245, Consumptive Use Permit #5087-5. The District authorizes the use of 0.096 million gallons per day (mgd) of groundwater from the Upper Floridan aquifer for irrigation of agricultural cultivated crops through 2044. The withdrawals used by this project will consist of Groundwater from FAS - Upper Floridan aquifer via 2 active wells in Flagler County, located in Sections 16 and 9, Township 12 South, Range 29 East. This project is known as Orange Grove Field.
