The staff of the St. Johns River Water Management District has completed their review of the consumptive use permit application(s) described below. Based on this review, the District gives notice of its decision to grant permit(s) for the application(s) described below. The District is providing you this notice because you are either listed as a County Interested Person or you expressed an interest in one or more of these application(s).

The District gives notice of its decision to grant permit(s) for the following application(s):

Glenn Beck, 12500 Overstreet Rd, Windermere, FL 34786-6517, Consumptive Use Permit #2850-4. The District authorizes the use of 0.108 million gallons per day (mgd) of groundwater from the Upper Floridan aquifer for irrigation of 96 acres of citrus and maximum daily withdrawals of 6.22 mgd of groundwater from the Upper Floridan aquifer for crop (freeze) protection through 2044. The withdrawals used by this project will consist of Groundwater from FAS - Upper Floridan aquifer via 2 active wells in Lake County, located in Section 34, Township 21 South, Range 24 East; Section 3, Township 22 South, Range 24 East. This project is known as Beck Grove.
