HR Rivington, LLC, 5850 T G Lee Blvd, Ste 200, Orlando, FL 32822-4408 application #184853-2. The project is located in Volusia County, Section 9, Township 19 South, Range 30 East, and includes 24.94-acres. The Environmental Resource Permit application is for Minor Modification of Permit No. IND-127-184853-1 for Rivington Phase 4 Stormwater Management System to formally identify and allocate excess treatment and attenuation for Fort Florida Road Improvements. The receiving waterbody is the St. Johns River (Above Wekiva River).

Dean River, LLC, PO Box 700173, Saint Cloud, FL 34770-0173 application #207194-1. The project is located in Volusia County, Section 23, Township 17 South, Range 29 East. The Environmental Resource Permit application is for construction and operation of a Stormwater Management System for a 78.88-acre project known as Dean River. The receiving waterbody is St Johns River.
