The District gives notice of its intent to grant a permit for the following application(s):

City of Jacksonville , 214 N Hogan St Fl 3, Department Of Parks & Recreation, Jacksonville, FL 32202-4240 application #25881-2. The project is located in Duval County, Section 54, Township 1 South, Range 27 East, and includes 0.2-acres. The Environmental Resource Permit application is for Letter Modification of Permit No. 40-031-25881-1 for BLUE CYPRESS PIER AND BOARDWALK, a 0.045 - acre project to be constructed and operated for a project known as BLUE CYPRESS PIER AND BOARDWALK. The receiving waterbody is the ST JOHNS RIVER ABOVE TROUT RIVER.
